NARRATIVE

Initial Information

On 08-29-16 at approximately 1006 hours, I Officer T. Lindvall #2417 (Unit 3A43), was dispatched to Spring Creek Detention Center located at 3190 E. Las Vegas Ave in reference to an assault/riot that had occurred on the evening of 08-28-16. There were multiple suspects and multiple victims. Officer J. Flores #3640 was dispatched as the primary officer to Spring Creek.

Upon arrival, Officer Flores and I made contact with staff. There were 9 suspects identified as taking part in the disturbance on 08-28-16 in Tiger Pod. There were 4 victims identified in the disturbance. I interviewed two of the victims at Spring Creek, [REDACTED] and [REDACTED]

Statement from [REDACTED]

[REDACTED] is currently an inmate at Spring Creek and has been since [REDACTED]. [REDACTED] said he is due to be released in [REDACTED]. [REDACTED] said the only issue he has had has been with [REDACTED] in Jaguar. [REDACTED] said he is currently in Tiger Pod. [REDACTED] said [REDACTED] thinks he stole his clothes when they were both at "Work and Learn". [REDACTED] said this allegation stems from when they were both at a half way house. [REDACTED] also said [REDACTED] has been telling people he had raped someone in the past.

[REDACTED] said on 08-28-16 they (Tiger Pod) was watching a movie (Star Wars The Force Awakens). [REDACTED] said he had not had any recent problems with anyone. [REDACTED] said he was sitting at a table watching the movie. [REDACTED] said he was paying attention to the movie. [REDACTED] said a "bunch" of people started hitting him. [REDACTED] said he was hit over 50 times he believes. [REDACTED] said he tried to get his head down. [REDACTED] said he was not able to see exactly who was hitting him, but thought it was [REDACTED], [REDACTED], [REDACTED], and [REDACTED].

[REDACTED] said Valentine pulled him away and put him in a cell.

I asked [REDACTED] if he could hear the parties saying anything? [REDACTED] said he could hear one party say, "You're a bitch [REDACTED]". [REDACTED] said he could not tell who had called him that.

I asked [REDACTED] if he thought staff could or should have mace (or other less lethal options) to combat aggressive behavior? [REDACTED] thought that having something like that could help prevent assaults, or at least

[REDACTED] is currently an inmate at Spring Creek. [REDACTED] said he has been incarcerated at Spring Creek since [REDACTED] and is due to be released on [REDACTED]

[REDACTED] said he is currently in the Tiger Pod. [REDACTED] said he did not have any issues prior to 08-28-16. [REDACTED] said he believes he was targeted on 08-28-16 because he is an acquaintance of [REDACTED]. [REDACTED] said he was sitting around on the phone while everyone was watching Star Wars. [REDACTED] said he knew something was about to happen. [REDACTED] said some people were grabbing chairs and walking around.

[REDACTED] said he believes [REDACTED] was targeted because he supposedly had been talking shit about Crips.

[REDACTED] said [REDACTED] was assaulted by [REDACTED], [REDACTED], [REDACTED], and [REDACTED]. [REDACTED] said they started hitting [REDACTED] and kept hitting him. [REDACTED] said after putting the phone down, he was hit 2 times in the face by [REDACTED]. [REDACTED] said he tried to cover his head and keep himself protected. [REDACTED] said he was able to get away from the assault with the help of staff. [REDACTED] said after about 2 minutes, he was assaulted by [REDACTED]. [REDACTED] said [REDACTED] was on the ground and was able to break away from staff. [REDACTED] said he was struck in the back of the head. [REDACTED] said he covered the back of his head with a chair.

[REDACTED] said he was able to get away and go upstairs with the help of staff.

I asked [REDACTED] what steps could be made in preventing assaults from this occurring? [REDACTED] said he thought there should be more staff working and the people that are not involved in the disturbance need to be taken away from the scene. [REDACTED] did think that having mace or other less lethal options could help protect staff and other inmates.

INITIATING INFORMATION

On 08/29/2016 at approximately 1017 hours, I, Officer J. Flores, 3640, and Officer T. Lindvall, 2417, were dispatched to 3190 East Las Vegas Street at the Spring Creek Youth Services Center. Call screen details indicated that the disturbance occurred last night and residents were attacked and then staff was attacked. Details continued that the residents were rioting and there were seven suspects and the suspects were in seclusion.

Upon arrival I contacted a staff member who informed me there was a large disturbance and it was gang associated. She also stated that there were nine prisoners and four victims and two of the victims were Spring Creek staff members. She showed me a video of the video surveillance footage that captured the incident. She stated this occurred on 08/28/2016 at approximately 2000 hours. The staff member informed me that in the area of Spring Creek where this occurred were mostly Crip gang members and they think were gang associated. She informed me that somebody had ordered a "hit" on one of the victims, [REDACTED] DOB: [REDACTED]. She stated this was the reason she thinks that the disturbance occurred.

Video surveillance footage captured time and date was at approximately 1756 hours on 08/28/2016. I observed a large group of kids, most of them sitting down in the room, with one staff member walking around. All of them appeared to be calm and I did not notice any kind of disturbance or anybody upset. I noticed the staff member was walking around talking to everybody. I then observed a male, who was later identified as [REDACTED] DOB: [REDACTED], and [REDACTED] DOB: [REDACTED] stand next to Mr. [REDACTED]. I noticed that both [REDACTED] and [REDACTED] appeared to grab a chair each and they were just holding it. I noticed that the male looked around as to see if there was any staff around. Staff member informed me that what [REDACTED] and [REDACTED] were doing was they were waiting until the staff member left the room so they could assault Mr. [REDACTED]. I then noticed [REDACTED] pick up a chair and then strike Mr. [REDACTED] over the head







Mr. Johnson stated after the incident with [REDACTED] his left knee was sore and informed me [REDACTED]

Mr. Johnson told me he heard [REDACTED] say, "I swear to god if anybody restrains my boys I will assault staff tomorrow. I put that on my dead dad." Mr. Johnson told me he saw [REDACTED] and [REDACTED] holding up two chairs and both of them were saying, "What do you want us to do [REDACTED]? Let me know." He also heard [REDACTED] scream, "Nobody can fuckin restrain me!"

I observed on the video surveillance footage after [REDACTED] broke away from the staff members that were attempting to restrain him, walk towards the back of the room. He then grabbed a chair and then slammed it against the wall. I observed him screaming at staff members and balling up his fists.




